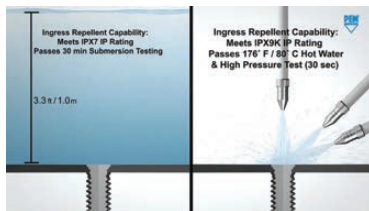

As a result, the existing order on imports of these products remain in place. The USITC’s public report on Steel Nails from China (Inv. 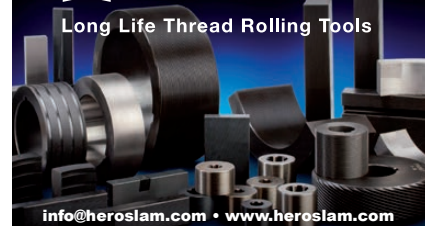
