Single-family housing completions rose through 2024, underpinning nail shipment growth. The Census Bureau logged 1.05 million completions in 2023, ensuring stability in the US carbon steel nail market. Longer schedules translated into larger onsite stockpiles of framing and finishing nails.

Additionally, the Canadian carbon steel nail market was valued at US\$92.76 million in 2024 and is anticipated to reach US\$133.03 million by 2033, growing at a CAGR of 4.21% during the forecast period.

Housing starts rebounded firmly

across Canada during 2023, reversing two subdued years. Multifamily permits led, supported by provincial incentives targeting urban density gains. This upswing has direct pull-through on framing, sheathing and siding schedules. Developers have reported cycle times compressing by three weeks versus 2021 averages.
